POLICIES

BOOKINGS: To secure a date, a signed bridal contract and \$100.00 deposit are required. This deposit is non-refundable. This deposit will include the scheduled trial & be put toward the client's total wedding day balance. The remaining balance will be due on day of the event. Accepted forms of payment include: CASH ONLY (unless specified) **Gratuity is appreciated.** A trial must be scheduled within 30 days from inquiry to hold the wedding date. Your date will not be held or guaranteed past the 30 days, until 100% of a deposit is received.

ADDITIONAL FEES: There is a minimum of applications for on site booking unless specified during inquiry. An on site fee may be charged if less than the required minimum.

ADDITIONAL ARTIST FEES: Our professional artists guarantee a smooth timeline for your event. Depending on party size & event times additional artists may be needed. Fee's may vary and are subject to change. Quote fee's for additional artist will be given at the time of inquiry.

TRAVEL FEES: Travel fees are quoted & agreed to upon initial inquiry. Travel fees apply for all pre-event makeup consultations as well as day-of appointments. A quoted travel/on site fee does not include travel to and from trial appointments. That pricing will be quoted separately depending on location.

DELAYS: A late fee of \$25.00 will be charged for every 30 minutes of delay when a client is late for the scheduled time, or if the scheduled makeup application exceeds the allotted time due to client delays. It is important for all parties to be on time to ensure the desired finishing time.

PARKING FEES: Where parking, valet or toll fees may be incurred. This amount will be included in the final bill and will be due on the day of the event.

LIABILITY: All brushes, tools, and makeup products are sanitized between every makeup application. Makeup products used are hypoallergenic. Any allergies and/or skin conditions should be reported by the client to the makeup artist prior to application and, if need be, a sample test of makeup may be performed on the skin to test reaction. Client(s) agree to release the makeup artist (Jena Huynh & all assistants) from liability for any skin complications due to allergic reactions.

PAYMENT: The final balance is due on the day of the event before the makeup artist departs — no exceptions. The person(s) responsible for the entire balance of payment is the person(s) whose name(s) appear on this contract.

CANCELLATION POLICY: You may cancel this contract at any time up to a 90 days prior to the date of service requested. After this period, you will be charged 50% of the quoted rate. If canceled less than 48 hours prior to the contracted date 100% of the quoted rate will be due. You may add or remove the number of applications for the day of service up to 90 days before the contracted date. After this period every application cancelled will require 100% of the service rate.
